### **OFFICIAL SET-UP DAY – Vendor & Car Corral**

Load in will be on Thursday, May 7<sup>th</sup> from 8 a.m. - 6 p.m. Vendors/Car Corral should enter through the North entrance (Gate 6) of the auction park.

### **Hours of Operation**

Friday & Saturday, May 8-9 auction begins at 10 a.m. ends around 6 p.m. All vendors need to be open for business on Friday & Saturday from 9 a.m. - 6 p.m. Gate opens to the public at 9 a.m.

### **Tear Down**

Saturday, May 9<sup>th</sup> auction is expected to end around 6 p.m. Once the crowd has cleared security will allow vehicles to enter the grounds.

### **GENERAL INFORMATION**

RM Auctions assumes no responsibility for any damage or loss by fire, theft or any other cause whatsoever. Vendors and spectators use the facilities at their own risk and agree to indemnify and save harmless RM Auctions, its agents and employees from any loss or liability including but not limited to costs of defense, arising from participation at events conducted by RM Auctions and/or held at the Auburn Auction Park. Vendors will indemnify and save harmless RM Auctions for any such loss or liability arising from conduct of any vendor towards another vendor or the public

RM Auctions reserves the right to reject application for space rental or renewal on the basis of unsatisfactory previous conduct, merchandise that does not fit within the scope of the event, or upon any other basis made in the sole determination and at the sole discretion of RM Auctions. RM Auctions also reserves the right to remove individuals who exhibit unsatisfactory behavior during an event. Misuse of any show credentials will result in ejection from Auction Park. Failure to comply with any of the rules and regulations may result in loss of the willingness of RM Auctions to renew a space rental or immediate removal from grounds.

#### ➤ **VENDOR SPACE USAGE RESTRICTIONS**

- Swap meet spaces shall be used for sale of product, NOT used as solely as camping or parking spaces.
- No selling of vehicles in the vendor space.
- All merchandise, vehicles and tent stakes must be contained within assigned space and vendors may not engage in any sales or business activities outside the assigned space without the written consent of an authorized agent of RM Auctions.
- All tent stake holes must be filled in at tear down. Failure to do so will result in a \$75 fine.

#### ➤ **CAR CORRAL SPACE USAGE RESTRICTIONS**

- No overnight camping in any car corral space.
- NO SELLING of parts or products of any kind in the car corral.
- All vehicles, lawn chairs, etc. must be contained within your assigned space(s). No tents in car corral.
- Vehicles being left on trailer/haulers are welcomed, **but must be approved by RMA**, and placed towards the back of the car corral.
- Free trailer parking is located outside of the vendor office at Gate 6.
- Car corral vehicles may exit each night after 5 p.m. and return each morning before 9 a.m.

- **No food or beverage sales.** Only contracted food vendors and concessionaires may sell food or beverages of any kind, including water.

- **Alcohol Policy:** Alcohol brought in on RM Auctions grounds is prohibited by the Indiana Alcohol & Tobacco Commission. Coolers will be checked at the gates. If alcohol is found, you will be removed from the grounds.
- **No selling of counterfeit products** of any kind. This includes sunglasses, purses, etc.
- **Vehicles used for restocking** may be brought in (with pass) between 7 a.m. and 9 a.m. during the event. All vehicles that are not part of the display/booth that are in the park after 10 a.m. will be towed unless approved and hidden in booth area.
- **Hauling Merchandise / Transportation on grounds.**  
No hauling passes are available between 10 a.m. and 5 p.m. on Friday and Saturday. No vendor vehicles will be allowed to enter or exit grounds between 10 a.m. and 5 p.m. on event days. Additional options for parts hauling are available. Please visit the vendor office should you need assistance hauling your parts to the gate.
- **No Subleasing of space.** The Vendor shall not assign, sublet or apportion the whole or any part of their assigned space or have representatives, equipment or materials from other firms than their own in their assigned space without the written consent of RM Auctions.
- **Transfer of space.** The transfer of renewal space is allowed only with the express authorization from RM Auctions. RM Auctions exclusively reserves the right to approve any and all transfer requests at its sole discretion. Criteria for the approval of transfer of space will be determined solely by RM Auctions and implemented and enforced as RM Auctions deems in the best interest of the company and the event.
- **No ATV's, gators, rangers, etc are allowed onto the grounds.** Please contact DEVER Golf Cart Rental at 859-455-9586 for more information.
- **Generators** are permitted as long as they do not pose a fire safety hazard, are too loud, or not properly vented. Generators causing excessive noise or fumes are strictly prohibited. Generators that vent exhaust fumes directly into adjoining vendor spaces are strictly prohibited. Generators should be vented above vehicles and crowd.
- **Pets** are strongly discouraged for health and safety reasons. If you cannot make other arrangements for boarding, your pet must be on a leash and policing and clean up after it is required. Your pet must be under your control at all times, and you are fully responsible for its actions. Any offensive or unsafe action by your pet may result in expulsion without refund.
- **Trash Removal:** Vendors will be charged \$75 for removal of excessive trash that is not properly bagged. Trash bags are available at Vendor Office. It is mandatory that all cardboard boxes be broken down and stacked by a trash cans for removal.
- **Tent Rental:** You may use the tent company of your choice. RM Auctions recommends Muttons Rental 260-432-8636. RM Auctions shall retain the right to ban any tent or structure that does not meet applicable safety standards.
- **Vehicle Passes:** Only **one** vehicle pass will be issued per space. Vehicle pass **MUST** be affixed permanently to vehicle's windshield prior to entry grounds. The sticker covers admission for up to two people in the vehicle. Any additional individuals in the vehicle must present a separate pass or pay admission to enter the grounds.
- **CANCELLATION:** No money paid pursuant to this agreement will be refunded in the event of a cancellation less than 15 days before the event. Any refunds for cancellations 15 days or more prior to the date of the event will be made subject to deduction of a service charge of \$25 per space.
