Car Corral Office Hours

Monday & Tuesday 8 a.m. - 6 p.m.
Wednesday - Sunday 8 a.m. - 6:30 p.m.

Gate & Ground Security

- Gate 9 begins 24-hour security: Sunday, August 25th @ 6 p.m.
- Gate 6 begins 24-hour security: Wednesday, August 28th at 8 a.m. - Sunday, Sept 1st at 6 p.m.
- Gate 4 begins 24-hour security: Wednesday, August 28th at 8 a.m. - Sunday, Sept 1st at Midnight

Official Load In Day

Load in will begin Wednesday, August 28th from 9 a.m. - 6 p.m. Car Corral vehicles should enter through the North entrance by the car corral office (Gate 6) of the auction park.

CAR CORRAL CREDENTIALS

Credential Packets may be picked up any time after August 12th 2019 at the Auburn Auction Park Main Office. Credentials may also be picked up upon check-in located at (Gate 6) beginning August 28, 2019. Packets include the following; 2 weekend passes per car corral space, vehicle sticker, and a vehicle release form. Credential packets will not be mailed.

Car Corral Vehicle Check In Procedures

A staff member will be available at Gate 6 upon your arrival for vehicle check in. You will receive your Vehicle Release Form to "enter" and or "exit" the grounds. For quicker check in please have your car corral sticker placed on your vehicle (directions are on the back of sticker) and your car corral vehicle release form completed. If your vehicle is sold during the event please sign the release form and give it to the buyer for easy exiting.

CAR CORRAL SPACE RESTRICTIONS

- No overnight camping in any car corral space.
- NO SELLING of parts or products of any kind in the car corral.
- All vehicles, tent stakes, lawn chairs, etc. must be contained within your assigned space(s).
- Vehicles being left on trailer/haulers are welcomed, **but must be approved by RMA** and placed towards the back of the car corral.
- Free trailer parking is located outside of Gate 6.
- Car Corral vehicles may exit each night and return each morning.

- **NO ATV's, Gators, Rangers, etc. are allowed on the grounds.** Please contact **DEVER Golf Cart Rental at 859-455-9586** for more information. All personal golf carts will need to purchase a golf cart permit through DEVER Golf Carts.
- **Pets** are strongly discouraged for health and safety reasons. If you cannot make other arrangements for boarding, your pet must be on a leash and policing after it is required. Your pet must be under your control at all times, and you are fully responsible for its actions. Any offensive or unsafe action by your pet may result in expulsion without refund.
- **Tent Rental:** You may use the tent company of your choice. RM Auctions recommends Mutton Rental 260-432-8636. RM Auctions shall retain the right to ban any tent or structure that does not meet applicable safety standards.
- **CANCELLATION:** No money paid pursuant to this agreement will be refunded in the event of a cancellation less than 15 days before the event. Any refunds for cancellations 15 days or more prior to the date of the event will be made subject to deduction of a service charge of \$25 per space.
